Brady Nelson from Crawford & Associates stated that the DEC sent them a motion of intent with an authorization number. Brandy Nelson and Jay Trap will do a site visit the week of April 11<sup>th</sup> with Mr. Amrod to go over the list of conditions from the 2008 site plan approval and check off all the ones he has completed prior the May meeting. Amrod Enterprises was asked to return to the May meeting.

Chairman Philip Schmidt responded to a complaint from the public about Sloop Brewing and asked the Building Department to check in with them and go over the conditions placed upon them .

Members of the town of Livingston Zoning Board of Appeals gave the Planning Board a brief synopsis of a new Elder care Law from the State and asked for our input.
