Robert Schumer and Ruth Oxenburg submitted a Site Plan application due to a denied building permit for 80 John Bay Road. Per Local Law #1 for the year 2017: Solar panels used by residences and businesses, pole mounted/free standing shall be allowed in all districts with site plan approval and public hearing. Property in LDR2 29.87 acres Fee paid. It will be a top of ground mount instillation. 5 groups of 8 panels. Public hearing scheduled for May 1 st at 7:02. To be advertised.

Chairman Schmidt will recuse himself from this application and will not cast a vote.

- 3. Attorney Ken Dow submitted a detailed letter. Siting various reasons not to approve this application.
- 4. Ann Macpherson concerned that the volunteer fire department would not be able to handle a fire of that type.
- 5. Fire Chief Paul Jahns explained that the fire company has Haz Mat training and the Columbia County Haz Mat would be involved. Upset that this is a slap in the face for all volunteers.
- 6. Gut Hughes Jr. said that the question of the fire volunteers should be addressed to the Fire Commissioner not the Planning Board.
- 7. Elizabeth Nyland requested a full SEQRA and wants to follow the Master Plan rules. Size of project and concerned for the lack of concern from Global representatives.
- 8. Charles Schneider gave a history of the 4 corners at Bells Pond. 5 gas stations and 3 diners the roads already have high levels of traffic even before this project. 38 B & B and 3 4 wedding venues in this area. He approves the application.
- 9. Dave Fingar asked the Board to due diligence and hopes the project is passed.
